

Our laminates are crafted with both aesthetics and durability in mind. When used as directed and with proper care, they are designed to maintain their beauty and functionality for years to come.


AMINATES

- Cleaning Use water and a clean, non-abrasive cloth for regular cleaning.
- **Stubborn Stains** For tougher stains, apply mild household cleaners like Colin, and gently wipe with a non-abrasive cloth.
- Avoid Harsh Chemicals Refrain from using abrasive liquid cleaners, bleach, or harsh chemicals, as these can damage the laminate surface.
- **Heat Exposure** Do not place hot cookware directly on the laminate. Prolonged exposure to temperatures above 30°C may damage the surface.
- **Proper Use** Avoid using the laminate for unintended purposes (e.g., ironing, chopping, hammering, or exposing to open flames).
- Outdoor Use Not recommended for outdoor applications where exposure to direct sunlight and harsh weather conditions is likely.
- UV Rays Direct exposure to UV rays may deform the laminate.
- Gloss Surfaces These are best suited for vertical applications only.
- Avoid Solvents Do not use thinner, toluene, or similar solvents, as they may cause discoloration.
- Storage: Store laminates at temperatures below 30°C.
- Compliance Our laminates conform to internationally recognized technical standards.
- Thickness Tolerance Laminates have a thickness tolerance of +/-10%.
- **Protective Film** Ensure the protective film is peeled off after installation.
- **Humidity Concerns** Acrylic can be compromised when bonded in extremely humid conditions.
- Uneven Substrate Debonding may occur in certain areas due to an uneven substrate surface.
- Adhesive Issues Using water-based synthetic resin adhesives, other than PEVA (Polyethylene Vinyl Acetate Co-polymer), can affect bonding quality.
- Moisture Loss Substrates losing moisture after installation can lead to bonding failures.
- Insufficient Pressure Inadequate pressing during the bonding process can result in poor adhesion.
- Oversized Sheets The use of oversized acrylic/PVC laminate sheets (over 8 ft x 2 ft) can pose installation challenges.



Facts



Acrylic are bonded in extremely humid conditions



Use of water base synthetic resin adhesive any other the PEVA (Polyethylene Vinyl Acetate Co-polymer)



When substrate loses moisture after installation



Debonding in certain areas because of uneven substrate surface



Insufficient or lack of pressing during the bonding period of laminate



Use of extremely large acrylic/PVC laminate sheets (more than 8 ft x 2 ft long)

To avoid de lamination / air bubbles in between ply and laminate the above steps should be taken care of. Bonding of acrylic sheets shouldn't be completed under high humidity

Reasons for air bubble formations on Acrylic Sheets
